For safety reasons you must be an entrant to display your drum.

- **Entry forms and fees:** by Thursday 18 July 2019, 5pm to 35 Willow St, Killarney or online at www.killarneybonfirenight.com.
- **Drum Delivery:** Saturday 20 July 2019 between 9am and 2pm.
- **Entry Fee:** \$15 plus booking fee (includes exhibitor entry to the event)

Drum Categories



Category One 44 Gallon Drum

Drums may be full or half 44 Gallon drums.

Drums may be decorated or refashioned, but must still be functional as a fire drum.

Best New Exhibit Prize



Category Two Other Metalwork

Other metalwork, fire pits and braziers.

Eligible for:

Jackpot Prize
Best New Exhibit Prize



Category Three Family Drum

Open to new entries and exhibits from previous years and new entries.

Exhibits do not have to be exhibitors own work.

Entries will be assessed for safety only.

Create

- **Create or purchase a beautiful, functional and safe fire drum.**
- (See our facebook page for some inspiration.)
- Safe and stable.
- No sharp "sticky out" bits. (Sharp edges need to be turned.)
- No accelerants
- Reduce tripping hazards
- Pre-burn to ensure no fumes on the night.
- Clean of any flammable or fume producing material.

Enter

- **Enter your drum**
- Pick a Category
- Go to www.killarneybonfirenight.com to enter and let us know you are coming.
- Late Entries may not be accepted.
- Enter by **Thursday 18 July 2019 by 5pm**

Deliver

- **Deliver and set up**
- Killarney Showgrounds, Willow St, Killarney by 2pm **Saturday 20 July 2019**
- Drum Stewards organise the fire drum exhibition. See them for your paperwork and to get your location.
- Bring Drums empty. We supply wood.
- Reduce tripping hazards. All wood to be stored safely at drum site.
- Ensure drums are stable and secure.

Attend

- **Attend and supervise your drum**
- Killarney Bonfire Night is on **Saturday 20 July, 2019**
- Exhibitor parking is available on the southern side of the arena.
- Judging begins at 4pm.
- The Rural Fire Service will light drums after they are judged.
- Unsafe or unsupervised drums will not be lit.
- The exhibitor remains responsible for the safety of their drum during the event.
- Drum Hosts help oversee the crowd during the event.
- Advise a Drum Host if you are leaving before 9pm.

Pick-Up

- **Pick up your drum**
- Remove drums on Sunday 21st July.
- Children to be in the immediate supervision of an adult at all times.
- Clean up any rubbish, coals, or embers around your drum area. Rakes, wheelbarrows and rubbish bags are available.
- Any remaining embers in drums to be disposed of safely into main bonfire area.
- Killarney Rural Fire Service will be available to extinguish drums from 8am to 9am on Sunday morning. Also by arrangement at the close of the event.
- ***Do not leave the grounds with embers in your drum.***
